Implementation of cooperation agreements:

Within the framework of the concluded cooperation agreements, the following activities are carried out:

- **Seminars for manufacturers** on current issues of registration of drug products according to the EAEU and national guidelines;

Thus, for Russian applicants, a seminar was prepared on the specifics of preparing Module 1 of the registration dossier in the Republic of Belarus when registering according to Eurasian rules, a detailed algorithm was prepared for working with CETHS when submitting a dossier.

- Cooperation between expert organizations on the harmonization of expert approaches to the assessment of registration dossier materials

Approaches to the examination of a validation report and an analytical report on the bioequivalence of a drug product. An example of interaction with expert organizations from far-abroad countries: a series of online consultations with the Cuban regulatory authority during the registration of a Cuban vaccine for the prevention of coronavirus infection.

- Consulting representatives of companies representing the interests of domestic and foreign manufacturers in accordance with the list of questions provided in advance;

Training seminars on the following topics were in great demand:

Common mistakes when developing and implementing a risk management plan for a drug product.

Routine and extra risk mitigation measures in pharmacovigilance.

Handling the information about adverse drug reactions.
